## Milford First United Methodist Church Financial information for Purchase of Columbarium Niche

The cost per Niche will be \$3,000.00 for current members of the Milford First United Methodist Church, as well as United Methodist Clergy. The cost for nonmembers will be \$4,000.00. This cost will include the use of the Niche, any opening of the Niche for inurnment purposes, and the inscription of one name and set of dates. The cost of a second name and set of dates will be the responsibility of the Certificate Holder and will be at actual cost of inscription at the time. Inscriptions will include the name of the deceased, the year of birth and year of death only. There will be no exceptions.

A deposit of \$1,500.00 must accompany the Application for Purchase of Columbarium Niche. The balance must be paid within twelve(12) months of the date of approval of the application. Payment must be paid in full before a certificate of Inurnment Rights can be issues. A reserved Niche may not be used until the Certificate of Inurnment Rights has been issued.

All payments must be made in cash or check payable to "Milford First United Methodist Church." Credit card payments will be accepted.

The right to use a Niche may not be sold or transferred in any manner. An unused Niche may be surrender by the purchaser, upon written notification, back to the church only. A full refund will be given, less an administrative fee of \$250. The legal title to all Niches shall always remain with the Church.
